**ARTICLES OF INCORPORATION**

OF

**TOTAL INTERNATIONAL CAREER CENTER, INC.**

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The corporate name for the corporation (hereinafter called the "corporation") is TOTAL INTERNATIONAL CAREER CENTER, INC.

**SECOND:** The address, wherever located, of the principal office of the corporation, if known, is 590 East 49<sup>th</sup> Street, 2<sup>nd</sup> Floor, Hialeah, Florida 33013.

**THIRD:** The mailing address, wherever located, of the corporation is 590 East 49<sup>th</sup> Street, 2<sup>nd</sup> Floor, Hialeah, Florida 33013.

**FOURTH:** The number of shares that the corporation is authorized to issue is two hundred, all of which are without par value and are of the same class and are to be Common shares.

**FIFTH:** The street address of the initial registered office of the corporation in the State of Florida is 590 East 49<sup>th</sup> Street, 2<sup>nd</sup> Floor, Hialeah, Florida 33013.

The name of the initial registered agent of the corporation at the said registered office is Julio E. Torrecilla. The written acceptance of the said initial registered agent, as required in Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.


**SEVENTH:** The purposes for which the corporation is organized, are to engage in the operations of a vocational school as defined in Section 246.203(1) of the Florida Statutes and the Florida Business Corporation Act.

**EIGHTH:** The duration of the corporation shall be perpetual.


**NINTH:** The corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have the power to indemnify under said provisions from and against any and all of the expenses, liabilities, and other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified maybe entitled under any Bylaw, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.

**TENTH:** Whenever the corporation shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act.
