ARTICLES OF INCORPORATION OF MODERN THERAPEUTICS, INC.

THE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION WHO IS COMPETENT AS AN INCORPORATOR PURSUANT TO THE PROVISIONS OF SECTION 607, <u>FLORIDA STATUTES</u>, DESIRING TO ASSOCIATE FOR THE PURPOSE OF FORMING A CORPORATION PURSUANT TO CHAPTER 607, <u>FLORIDA GENERAL CORPORATION ACT</u> AND PURSUANT TO THE PROVISIONS OF THE STATUTES OF THE STATE OF FLORIDA PROVIDING FOR THE FORMATION, LIABILITIES, PRIVILEGES AND IMMUNITIES OF A CORPORATION FOR PROFIT, DO HEREBY CERTIFY AS FOLLOWS:

ARTICLE I NAME OF CORPORATION

The name of the corporation is and shall be: Modern Therapeutics, Inc.

ARTICLE II PRINCIPAL PLACE OF BUSINESS

Any action which may be taken at a meeting of the directors may be taken without a meeting, provided that a consent in writing setting forth the action so to be taken, signed by all of the directors, is filed in the minutes of the proceedings of the board of directors.

ARTICLE XVI AMENDMENT OF ARTICLE OF INCORPORATION
