ARTICLE I - NAME

The name of this Corporation is **TEDEMIL & SALTOM CORPORATION**

ARTICLE II - PURPOSE

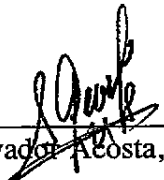
ARTICLE VIII - INDEMNIFICATION

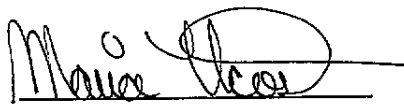
