The Members of **Lyons & Lurvey, P.A.** (the "Professional Association") met on March 27, 2013 pursuant to a meeting of the members duly noticed for the purpose of amending the Articles of Incorporation, or notice was otherwise waived. The undersigned President of the Professional Association hereby states that: (a) only one voting group was entitled to vote; and (b) the number of votes cast for the amendment by the members of this voting group was sufficient for approval.

WHEREAS, the Articles of Incorporation of the Professional Association were initially filed with the Florida Department of State on September 20, 2000, and were assigned document no. P00000089769;

WHEREAS, the Articles of Incorporation of the Professional Association were amended on January 6, 2003, changing the name of the corporation to: Lyons, Lurvey and Exposito, P.A., and authorizing additional shares;

WHEREAS, the Articles of Incorporation of the Professional Association were amended on January 30, 2007, changing the name of the corporation to: Lyons & Lurvey, P.A.

WHEREAS, the Articles of Incorporation of the Professional Association were amended on January 1, 2009, issuing 10,700 shares of capital stock and naming Christopher G. Lyons and Daniel Lurvey as shareholders;

NOW THEREFORE, at the meeting held on March 27, 2013, the following amendments to the Articles of Incorporation were adopted:
