The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

**ARTICLE I**

**EFFECTIVE DATE**

**NAME AND MAILING ADDRESS**

The name of this corporation is EMERALD COAST CONSTRUCTION OF NORTHWEST FLORIDA, INC. and the corporate mailing address is 5805 Saufley Field Road, Pensacola, Florida 32526.

**ARTICLE II**

**DURATION**

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgment of these Articles of Incorporation.

**ARTICLE III**

**PURPOSE**






