

ARTICLES OF INCORPORATION

OF

ARTICLE: I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the Corporation shall be: LARINO SUPPLY, INC., and the principal place of business is: 1400A North Federal Highway, Hollywood, Florida 33020.

ARTICLE II. TERM OF EXISTENCE

ARTICLE XIV. DIVIDENDS

Dividends may be paid to Shareholders (only out of the unreserved and unrestricted earned surplus of this Corporation).

ARTICLE XV. MANAGEMENT OF CORPORATION BY DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business affairs of this Corporation shall be managed under the direction of the Board of Directors of the Corporation.
