ARTICLES OF INCORPORATION

OF

CURRY TRANSPORTATION, INC.

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - Name

The name of this corporation shall be:

This corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The board of directors may authorize and require the payment of reasonable expenses incurred by directors in attending meetings of the board of directors.


