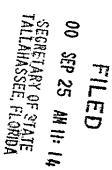

ARTICLES OF INCORPORATION

OF

The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be Concrete Wake Products, Inc.. The principal place of business of this corporation shall be 1126 S.E. 12th Court, Cape Coral, Florida 33990-3648.
