ARTICLES OF INCORPORATION

The undersigned incorporator, a natural person of legal age, for the purpose of forming a subchapter S corporation in accordance with the Florida Business Corporation Act, Chapter 607, Florida Statutes, hereby subscribes to, acknowledges and adopts the following Articles of Incorporation.

ARTICLE I Name

The name of the proposed corporation shall be YourLoanSupport.com, Inc.

ARTICLE II Duration

This corporation shall commence existence on the date of the execution and acknowledgment of these Articles, or on filing of these Articles if that shall occur more than five days thereafter, and shall exist perpetually thereafter, unless sooner dissolved according to law.

ARTICLE III Nature of Business

This Corporation is formed for the following purposes and shall have the following powers:

1. To engage in any lawful business and to own, lease and/or operate offices for that purpose.

ARTICLE V Initial Offices and Registered Agent
