### **ARTICLE III PURPOSES**

The general nature and purposes of business to be transaction, promoted and carried on by the corporation are as follows:

- (a) To engage in every aspect in the practice of a real estate agent, and all its fields of specializations, as are engaged in by real estate agents;

## **ATTACHMENT "B"**

### **ARTICLE IV SHARES**

- (a) The maximum number of shares of stock that this corporation is authorized to have outstanding at any time shall be 5,000 shares of common stock at One Dollars (\$1.00) per share value.
- (b) The consideration to be paid for each share shall be payable in lawful money or property, labor or services;
