## ARTICLES OF INCORPORATION OF COMPUTER DOMAIN, CORP.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### ARTICLE I NAME

The name of the corporation shall be: Computer Domain, Corp.

### ARTICLE II COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the President. This corporation's duration shall be perpetual.

### ARTICLE III PURPOSE

The corporation is being organized for the purpose of offering miscellaneous computer services and the administration of an e-commerce internet site called ProgramVault.com. The purpose of ProgramVault.com is to offer business to business contacts for programmers and software developers to sell the software that they developed to each other.

### ARTICLE IV PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 7902 NW 18<sup>th</sup> Court, Margate, FL 33063.

### ARTICLE V CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares.

### ARTICLE VI TRANSFER RESTRICTIONS

No shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any shares of the capital stock of this corporation to any person or entity other than other current shareholders in the corporation. Such offer shall be in writing, signed by the shareholder making the offer, and sent to the other shareholder by registered or certified mail. Any shareholder who receives a solicitation to either purchase the other shareholders shares, or an offer to have his shares purchased, shall have fifteen days in which to respond and make arrangements for either the sale or purchase of said shares.

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.

This Corporation shall indemnify any officer, director, employee, or agent, and any former officer, director, employee, or agent, to the full extent permitted by law.


#### **ARTICLE VIII AMENDMENT**

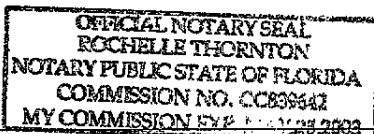
