ARTICLES OF INCORPORATION

OF

FLORIDA HARDWARE SALES COMPANY, INC

The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is: Florida Hardware Sales Company, Inc. The principal office and mailing address is 436 Cassat Avenue, Jacksonville, Florida, 32254.

ARTICLE 2.0 DURATION

The duration of the Corporation is perpetual.

ARTICLE 3.0 PURPOSE

The general purpose for which the Corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

ARTICLE 4.0 SHARES
