**ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation shall be TINA L. LEWERT, P.A., whose principal place of business and mailing address is 7050 Northwest 44<sup>th</sup> Street, #401, Fort Lauderdale, Florida 33319.

**ARTICLE II**

The period of duration of the corporation is perpetual.

**ARTICLE III**

The purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State, in the practice of law.

**ARTICLE IV**

The corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Capital Stock, with a par value of one dollar (\$1.00) per share.

**ARTICLE V**

The address of the initial registered office of the corporation is 7050 Northwest 44<sup>th</sup> Street, #401, Fort Lauderdale, Florida 33319, and the name of its initial Registered Agent at said address is Tina L. Lewert, Esq.

## ARTICLE VI

## ARTICLE VIII

The shareholders shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a stockholder's meeting, with not less than a two-thirds vote of the common stock.

## ARTICLE IX

The power to adopt, amend, alter, change, or repeal By-Laws shall be vested in the Board of Directors.

## ARTICLE X

The holders of the common stock of this corporation shall have preemptive right to purchase, at prices, terms, and conditions that shall be fixed by the Board of Directors, such of the shares of the stock of this corporation as may be issued for money (or any property or services) from time to time, in addition to that stock authorized by the corporation. The preemptive right of any holder is determined by the ratio of the authorized shares of common stock held by the holder to all shares of common stock currently authorized

ARTICLE XI

Pursuant to Florida Statute § 607.0203, the effective date of the commencement of corporate existence is the 17<sup>th</sup> day of September, 2000, which is the date of subscription and acknowledgement of the Articles of Incorporation. Said Articles are to be filed within five (5) days after such date.
