ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be TINA L. LEWERT, P.A., whose principal place of business and mailing address is 7050 Northwest 44th Street, #401, Fort Lauderdale, Florida 33319.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State, in the practice of law.

ARTICLE IV

The corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Capital Stock, with a par value of one dollar (\$1.00) per share.
