ARTICLE I - NAME

The name of this corporation is **GREEN ALTERNATIVES, INC.**,

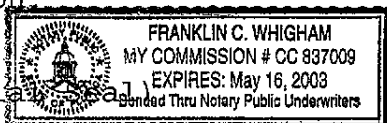
