2. The Articles of Incorporation of the Corporation are amended to provide for a new Corporation name as follows:



This Company shall be known as **Kennedee Group, Inc.**

3. This Amendment was approved and recommended by the board of directors to the Corporation's shareholders on August 26, 2002.


