

The undersigned subscriber to these Articles of Incorporation, David C. Fisher, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**CORPORATE NAME**

The name of this Corporation is 7 OF SOUTHWEST FLORIDA, INC. The principal office and mailing address of the corporation is 5701 Houchin Street, Suite 7, Naples, Florida .

**ARTICLE II**

**DURATION**

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

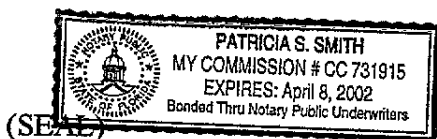
