**ARTICLES OF INCORPORATION
OF
THE COMPUTER SHOP, INC.**

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be THE COMPUTER SHOP, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 1012 E. Silver Springs Boulevard, Suite D, Ocala, Florida 34470.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is ten thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

**ARTICLE IV - INITIAL REGISTERED OFFICE
AND REGISTERED AGENT**

The initial street address of the registered office of this Corporation in the State of Florida shall be 1012 E. Silver Springs Boulevard, Suite D, Ocala, Florida 34470. The Board of Directors may from time to time move the registered office to any other address in Florida. 
ARTICLE VIII - DATE OF EXISTENCE
