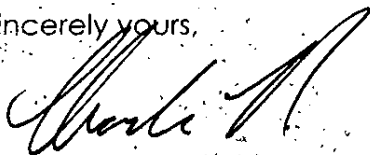

CORPORATE ACTION

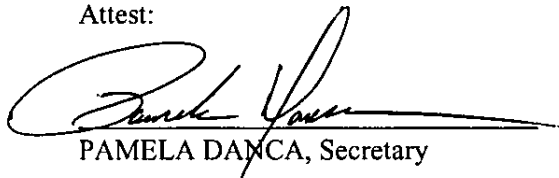
