The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the law of the State of Florida.

**ARTICLE I**

**NAME**

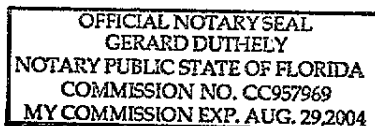
