The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: J & J SUN COAST DEVELOPERS, INC., 996 Deer Springs Road, Port Orange, Florida 32119.

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.
