This Corporation shall have perpetual existence upon filing of these articles.

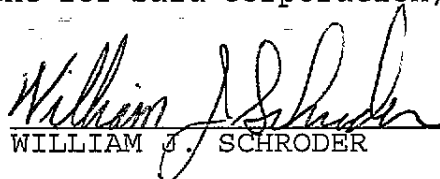

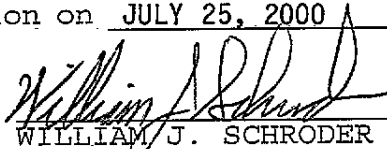

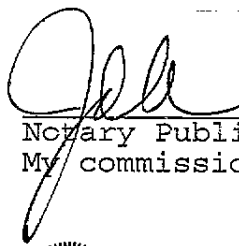
