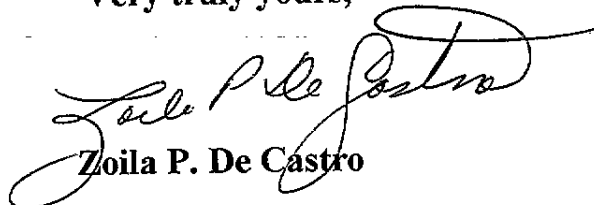

The undersigned, subscriber to these Articles of Incorporation, competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I- NAME

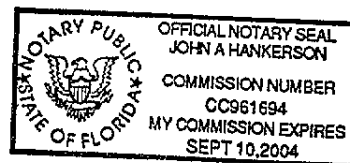
