# ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE I

The name of the Corporation shall be SOUTHEAST FIBERGLASS PRODUCTS, INC.

# ARTICLE II

The principal place of business and mailing address of this corporation shall be 587 Spindle Palm Drive, Indialantic, Florida 32903.

### ARTICLE III
