## ARTICLES OF INCORPORATION

of

ARTICLE I. NAME: The name of this corporation is Patti's Garage, Inc.

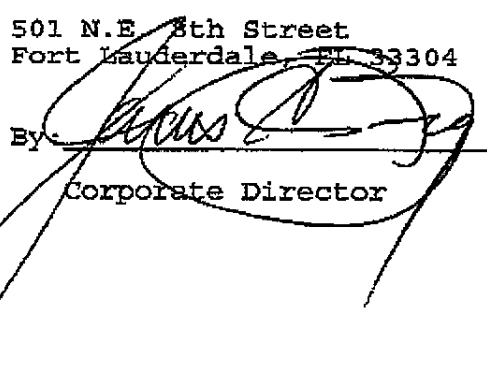
