ARTICLES OF INCORPORATION
OF

ARTICLE I. - CORPORATE NAME

The name of this corporation is Dory Funk Sports Management, Inc.

ARTICLE II. - PURPOSE

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida, including, without limitation, sports entertainment management.

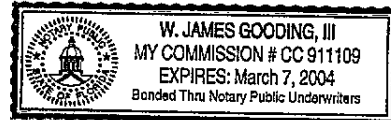

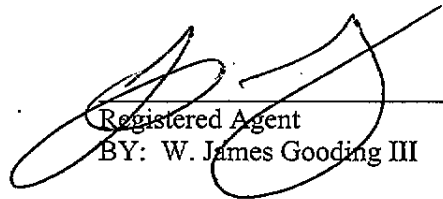
