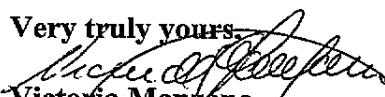

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of the corporation is "HURMANZ CORPORATION."

**ARTICLE II
DURATION AN BEGINNING OF CORPORATE EXISTANCE.**

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto.

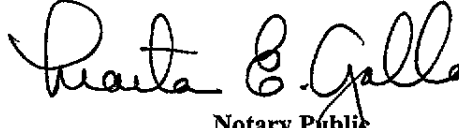
