ARTICLES OF INCORPORATION OF SECRETARY OF STATE THIRD LONG PRODUCTION, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt (s) the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: THIRD LONG PRODUCTION, INC.

ARTICLE II: NATURE OF BUSINESS
