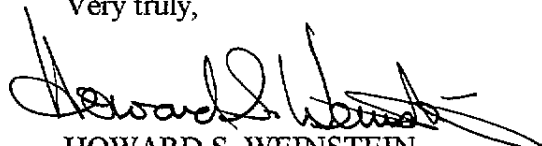
Dear Amendments Clerk:
