

NAME OF CORPORATION AND CORPORATE ADDRESS**

**ARTICLE II
DURATION**

This corporation has perpetual existence unless otherwise specified in these Articles of Incorporation.

**ARTICLE III
PURPOSES**


**ARTICLE XII

This corporation shall indemnify any officer or Director, or any former officer or Director, to the full extent permitted by law.


