

ARTICLES OF INCORPORATION

ARTICLE I NAME

THE NAME OF THIS CORPORATION IS Western Brokers Inc. and the mailing address is 3061 S.W. 11 Street Miami, Florida 33135

ARTICLE II DURATION

This corporation shall have a perpetual existence, unless sooner dissolved by law.

ARTICLE III PURPOSE
