ARTICLE I.

NAME

The name of this Corporation shall be: SATTLER CONSULTING, INC.

ARTICLE II.

PURPOSE



AMENDMENT

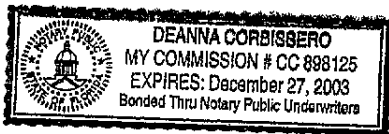


