The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

### ARTICLE ONE

The name of the corporation is Sarasota Business Ventures, Inc..

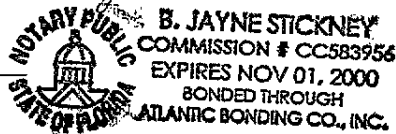

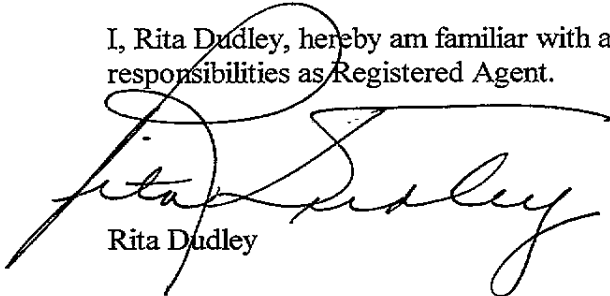
