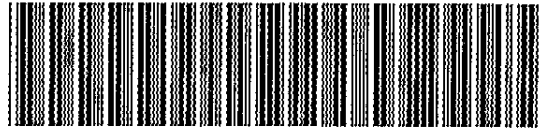



DILLINGER'S RECORD, INC., its Articles of Incorporation with the Florida Department of State on September 28, 2000. The document number of this corporation is P00000091935.


The executive officer, director, owner and shareholder of DILLINGER'S RECORDS is Charles J. Arnaud.
