Article 1 - Name

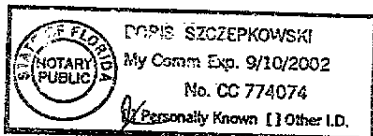


