ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is: **SkySeg International, Inc.** (the "Corporation"), and its address is 7200 N.W. 19th Street, Suite 308, Miami, Florida 33126.

DURATION

The duration of the Corporation is perpetual.

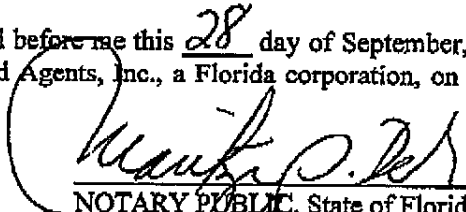
