ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is **Roval Foods Manufacturing Co.** (the "Corporation"), and its address is 8900 S.W. 117th Avenue, Suite B-205, Miami, Florida 33186.

ARTICLE II

DURATION

The duration of the Corporation is perpetual.

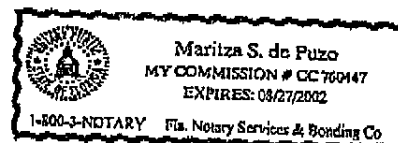
