ARTICLE 1. NAME.

The name of the Corporation is ROBERT B. CURTIS, O.D., P. A.

ARTICLE II. DURATION.

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III. PURPOSE.

This Corporation is organized for the purpose of transacting any or all lawful business in optometry.

ARTICLE IV. CAPITAL STOCK.

This Corporation is authorized to issue 100 shares of one dollar (\$1.00) par value common stock.


ARTICLE IX. INDEMNIFICATION.

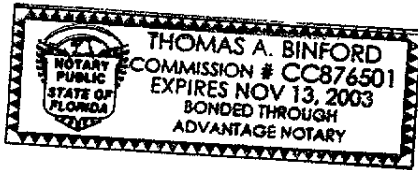


