OF

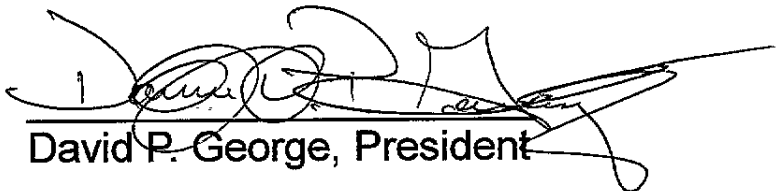
Federal Saw And Tool Companies Incorporated
