ARTICLE ONE NAME: The name of corporation shall be MESA TECHNOLOGIES, INC.

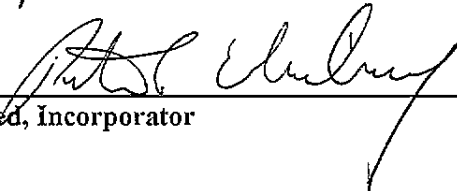

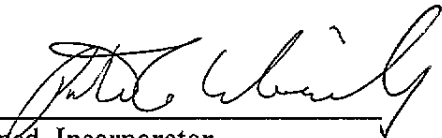

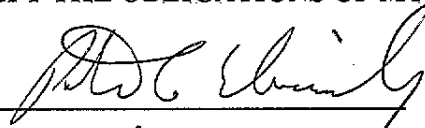
