ARTICLES OF INCORPORATION OF TAMARIND WAY CORPORATION

ARTICLE I

NAME

The name of the Corporation is TAMARIND WAY CORPORATION.

ARTICLE II

TERM OF CORPORATE EXISTENCE

The Corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation by the Department of State. PERMITTED ACTIVITY

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
