ARTICLES OF INCORPORATION  
OF

JUNIOR ACADEMY OF LAKE MARY, INC.

The undersigned incorporator, for the purpose of forming a corporation pursuant to Chapter 607 and 621 Florida Statutes (F.S.), hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME
