"MODEL ARTICLES OF INCORPORATION"

ARTICLES OF INCORPORATION OF

First Commercial Interim Bank

The undersigned, acting as director(s) for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt(s) the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be <u>First Commercial Interim Bank</u> and its initial place of business shall be 4600 West Kennedy Boulevard, Tampa, Florida 33609 in the City of Tampa, in the County of Hillsborough, and the State of Florida.

ARTICLE II

This corporation shall be organized as a successor institution in accordance with Section 658.40(4), Florida Statutes.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be <u>1.000</u>. Such shares shall be of a single class and shall have a par value of <u>\$2.00</u> per share. First Commercial Interim Bank will never commence banking operations, it is simply being formed as a vehicle to complete a bank holding company formation and reorganization in accordance with Section 658.40(4), Florida Statutes.

ARTICLE IV

The term for which said corporation shall exist shall be one (1) year.
