ARTICLE I - NAME

The name of the corporation is CHRIS' CLEAN CUT, INC..

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of filing the Articles with the Department of State.

ARTICLE III - PURPOSE

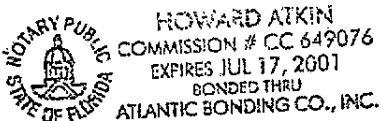

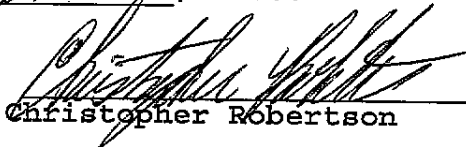

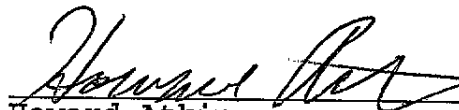
