ARTICLES OF INCORPORATION

OF

YANKEE DOODLIN' A SCRAPBOOKING STORE, INC.

THE UNDERSIGNED incorporators to these Articles of Incorporation, natural persons competent to contract, hereby desire to form a corporation for profit under the laws of the State of Florida, of the United States of America, by and under the provisions and statutes of that State, providing for the formation, liability rights, privileges, benefits and obligations conferred and imposed by said law on corporations organized pursuant to the provisions hereof, and does hereby make, subscribe and acknowledge and file these Articles of Incorporation as follows:

ARTICLE I. NAME OF CORPORATION

EFFECTIVE DATE

The name of this corporation shall be:

ARTICLE II. GENERAL NATURE OF BUSINESS
