ARTICLE I - Name

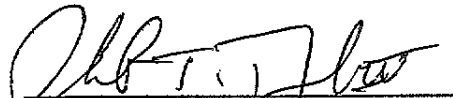
ARTICLE V - Initial Registered Office and Agent

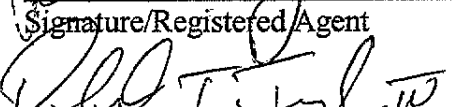
ARTICLE VI - Incorporator
