ARTICLES OF INCORPORATION

OF

BENSON AND BIRD AVIATION, INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation.

ARTICLE I. NAME

The name of the corporation is BENSON AND BIRD AVIATION, INC.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. NATURE OF BUSINESS
