- 1. Name. The name of the corporation is: LUCY LAYTON, INC.
- 2. <u>Purpose</u>. The corporation may engage in any legal business.
- Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of a par value of \$1.00 per share. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of a transfer or levy on such shares.
- 4. <u>Existence</u>. The corporation shall have perpetual existence. The corporation shall commence existence on the date of filing with the Secretary of State.
