

# ARTICLES OF INCORPORATION



TALLAH, SOLE, FLORIDA The undersigned attorneys, being duly licensed to practice Law under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, Florida Statutes Chapter 621, and other laws of the State, hereby make, acknowledge, and file the following Articles of Incorporation.

#### ARTICLE I -- NAME

The name of the professional service corporation shall be:

Lydolph, Porath & Warden, P.A.

# ARTICLE II --- PRINCIPAL OFFICE

The mailing address and street address of the principal office of the company shall be:

44A DUNE BREEZE LANE, SANTA ROSA BEACH, FL 32459

# ARTICLE III ---- PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of Law. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

#### ARTICLE IV ---- DURATION

The company shall commence its existence on the date these articles of incorporation are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of incorporation.

# ARTICLE V ---- CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company ten dollars (\$10.00) and other valuable consideration.

# ARTICLE VI --- ADDITIONAL CAPITAL CONTRIBUTIONS

Each Member shall make additional capital contributions to the company only on the unanimous written consent of all the members.

#### ARTICLE VII – CAPITAL STOCK

The capital stock of the professional service corporation shall be Six Thousand (6,000) shares of common stock having a par value of ten dollars (\$10.00) per share.

None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice Law in the State of Florida.

# ARTICLE X ---- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

# ARTICLE XI ---- TERMINATION OF EXISTENCE

The company shall be dissolved on the death, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in

the company, unless the business of the company is continued by the written consent of the remaining member(s).

Unless the articles of incorporation or regulations of the company require otherwise, any interest of a member is assignable only if the non-assigning member(s) provide written consent to the assignment. If a member assigns his or her entire interest, then he or she ceases to be a member or have any power to exercise any rights as a member. Each member cannot confer on a non-member all the attributes of the member's interest without the unanimous written consent of the non-transferring member(s).

## ARTICLE XV ---- AMENDMENTS

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation. An amendment to the articles of incorporation must be filed with the Department of State within 30 days after any of the following events: (a) the professional service corporation changes its name; (b) the articles contain a false or erroneous statement; (c) the time of dissolution as stated in the articles changes; (d) there is a time fixed for dissolution previously not provided for in the articles; or (e) the members desire to change any statement in the articles to more accurately reflect the agreement between them.

## ARTICLE XVI – ACTION WITHOUT A MEETING

The directors of this corporation may take action by written consent, as provided by law.

# ARTICLE XVII - PREEMPTIVE RIGHTS

Every shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
