THE UNDERSIGNED, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of this corporation shall be:

(The "Corporation") and it's initial address shall be:

**ARTICLE II**

**PURPOSE**

The Corporation may engage in any activity or business permitted by the laws of the State of Florida.

**ARTICLE III**

**AUTHORIZED CAPITAL STOCK**

### **LIMITED LIABILITY OF SHAREHOLDERS**

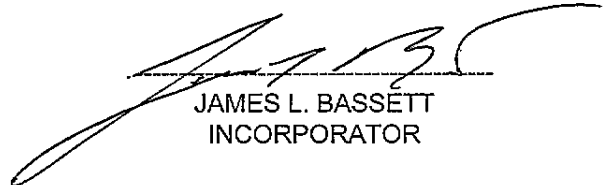
The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.

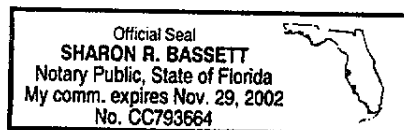

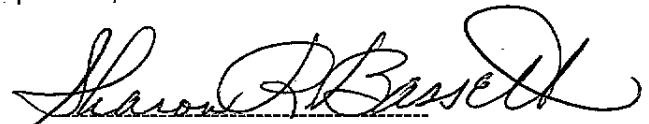

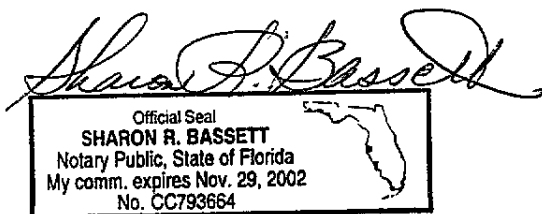
